

# North Wales Regional Committee

## Report to the Assembly

### 1. Introduction

1.1 The North Wales Regional Committee is one of the Assembly's four regional committees. Standing order 10 sets out the geographical areas of the committees and also states their remit.

1.2 Between July 2000 and July 2001 the Committee was chaired by Ann Jones. The other members of are Alison Halford, Gareth Jones, John Marek, Tom Middlehurst, Alun Pugh, Rod Richards, Peter Rogers, Janet Ryder, Karen Sinclair, Dafydd Wigley and Ieuan Wyn Jones. Eleanor Burnham replaced Christine Humphreys in May 2001. Lord Dafydd Elis Thomas is a member but does not attend meetings in view of his role as Presiding Officer.

1.3 The Committee met six times between July 2000 and July 2001. Details of the dates, venues, topics discussed and subsequent action taken are at annex 1.

### 2. Remit and Method of Working

2.1 The role of the regional committees, as defined by Standing Order 10.2, is to advise the National Assembly on matters affecting their regions, the effect of Assembly policies in those regions and the work of public bodies there.

2.2 The committee places great importance on encouraging public participation in its meetings and ensuring that the views expressed are fed back to the Assembly via Ministers and committee Chairs. After each meeting the Chair summarises the issues raised in a letter to the appropriate Minister which is copied to the relevant subject committee chair. At the start of each meeting the committee receives a report on action agreed at the previous meeting and any responses received.

2.3 The committee arranges its meetings around a specific theme. This has the advantage of simplifying the meeting structure and delivering a more focused audience.

2.4 During the year, the committee twice contributed to public consultation exercises. The first such meeting considered the *Communities First* programme and the second the consultation document "*Extending Entitlement: Supporting Young People in Wales*".

2.5 Public attendance at committee meetings was consistently high throughout the year,

averaging over 100. The meetings in Connah's Quay, Holyhead and Rhyl were particularly well attended.

2.6 In addition to the formal public meetings of the committee, informal briefing sessions were arranged with the North Wales Economic Forum and others. In November 2000 members met with the Forum to discuss the development of broadband capability in the region and North-South transport links. A briefing was also received from the Environment agency on the flooding at the time. In April 2001 members met with the Forum to discuss rail electrification, the development of the aerospace sector and ICT infrastructure.

2.7 These meetings proved a valuable means of exchanging views with the Economic Forum and ensuring that members were briefed on issues not covered at the committee's formal meetings.

2.8 Given his responsibility for the co-ordination of policy in North Wales, the committee issued a standing invitation to the First Minister to attend its meetings. The First Minister attended the meetings in Porthmadog, Holyhead and Rhyl and conducted open question and answer sessions with members of the public on each occasion.

### **3. Forward programme**

3.1 Eleanor Burnham was elected as Chair at the committee's meeting on 6 July 2001. The new Chair, in consultation with Members, will develop a work programme to ensure that the committee continues to provide a link between the National Assembly and local communities in the region.
